

## Operation Policy for the Facebook Page of the “Tokyo Financial Award”

### 1 Basic Operation Policy for the Facebook Page

- The operation of the Facebook Page of the “Tokyo Financial Award” (hereinafter referred to as “This Page”) is undertaken by Tokyo Financial Award Secretariat (hereinafter referred to as the “Trustee”) on consignment from the Tokyo Metropolitan Government.
- It is not intended that the Tokyo Metropolitan Government nor the Trustee read and/or reply to all the comments, messages, etc. that are posted from the viewer of This Page (hereinafter referred to as the “User”). ### 2 Intellectual Property Rights

All intellectual property rights concerning all the information (text, images, videos, etc.) published on This Page are owned by the Tokyo Metropolitan Government or the original authors. ### 3 Prohibited Posts

Any post on This Page which is judged by the Tokyo Metropolitan Government and/or the Trustee to fall under the following categories may be deleted or blocked without notice.

- (1) Posts that violate or may violate laws and regulations
- (2) Posts that defame, slander or tarnish creditability of specific individuals, groups, etc.
- (3) Posts that are submitted for the purpose of political or religious activities
- (4) Posts that infringe copyrights, trademark rights, portrait rights and other intellectual property rights owned by the Tokyo Metropolitan Government or third parties
- (5) Posts that are submitted for the purpose of advertising, publicity, solicitation, sales activities and other purposes for profit
- (6) Posts that discriminate races, ideas, beliefs, etc. or fuel discrimination
- (7) Posts that are contrary to public order or morality
- (8) Posts that are false or not true
- (9) Posts that violate privacy, such as the ones containing personal information without consent of the person concerned
- (10) Posts that use/provide or may use/provide harmful programs

- (11) Posts that are submitted for the purpose of providing a link to the websites containing the posts from (1) to (10)
- (12) Posts that violate the *Terms of Service* set by Facebook
- (13) Other posts that are deemed inappropriate by the Tokyo Metropolitan Government and/or the Trustee

#### 4 Banning users

- The Tokyo Metropolitan Government and the Trustee also reserve the right to block Users who post comments which falls under above-mentioned Prohibited Posts. Those Users who hinder proper operation of This Page may be blocked permanently.
